Selected main SD Benefits of the PoA



<u>Energy:</u> thanks to the PoA, households have access to biogas, a clean renewable energy. The use of biogas is free and replaces household traditional fossil fuel consumption.



<u>Air:</u> reduction of the smell coming from open manure pit and the smoke from combustion of coal/firewood in the kitchen <u>Land:</u> treated manure is used as natural and highly efficient organic fertilizer for agricultural work.




Health & Safety:

UPM's Experience with UNFCCC's SDC Tool

THE INCENTIVES for PP:

- Mainly for marketing purpose:
 - Being able to mention it to potential clients when trying to sale project CERs (UNFCCC is a official, reputable and reliable source).
 - Get more visibility for our project on the EB website.

THE PROs:

- The SD Tool of the CDM is fairly simple to use. For our PoA, we just filled out the form online and the SDC report was generated automatically afterwards;
- The 12 indicators of the SD tool of the CDM are similar 12 SD indicators of the Gold Standard, so for a GS certified project, like ours, those indicators have already been evaluated by third-parties.



UPM's Experience with UNFCCC's SDC Tool

THE CONs:

- Based on our experience, few people has ever heard about the CDM SD tool;
- No visibility regarding traffic of the SDC web-page on UNFCCC CDM website, so difficult to evaluate the actual impact on project dissemination.
- What happens with PP's input at UNFCCC/EB, beside the presentation at the SD-Tool webpage?

OUR RECOMMENDATIONS:

- Awareness-raising campaign among project participants and buyers is needed in order to see real benefits for using the tool;
- For CDM projects (without GS certification), best would be to have thirdparty evaluation on the SD indicators.
- UNFCCC could evaluate and publish the SD-Tool input to underline the possible Co-Benefits of CDM projects.
