# Adaptive Governance

- Adaptive governance is an emergent form of environmental governance that is increasingly called upon to coordinate resource management regimes in the face of the complexity and uncertainty associated with rapid environmental change.
- Adaptive governance is the social conditions that enable ecosystem management through the implementation of adaptive management (Folke et al. 2005, Gunderson and Light 2006).
- Although the term “adaptive governance” is not exclusively applied to the governance of social-ecological systems, related research represents a significant outgrowth of literature on resilience, social-ecological systems, and environmental governance.
- Adaptive governance encompasses the social contexts that collectively mediate what humans want from ecological systems.



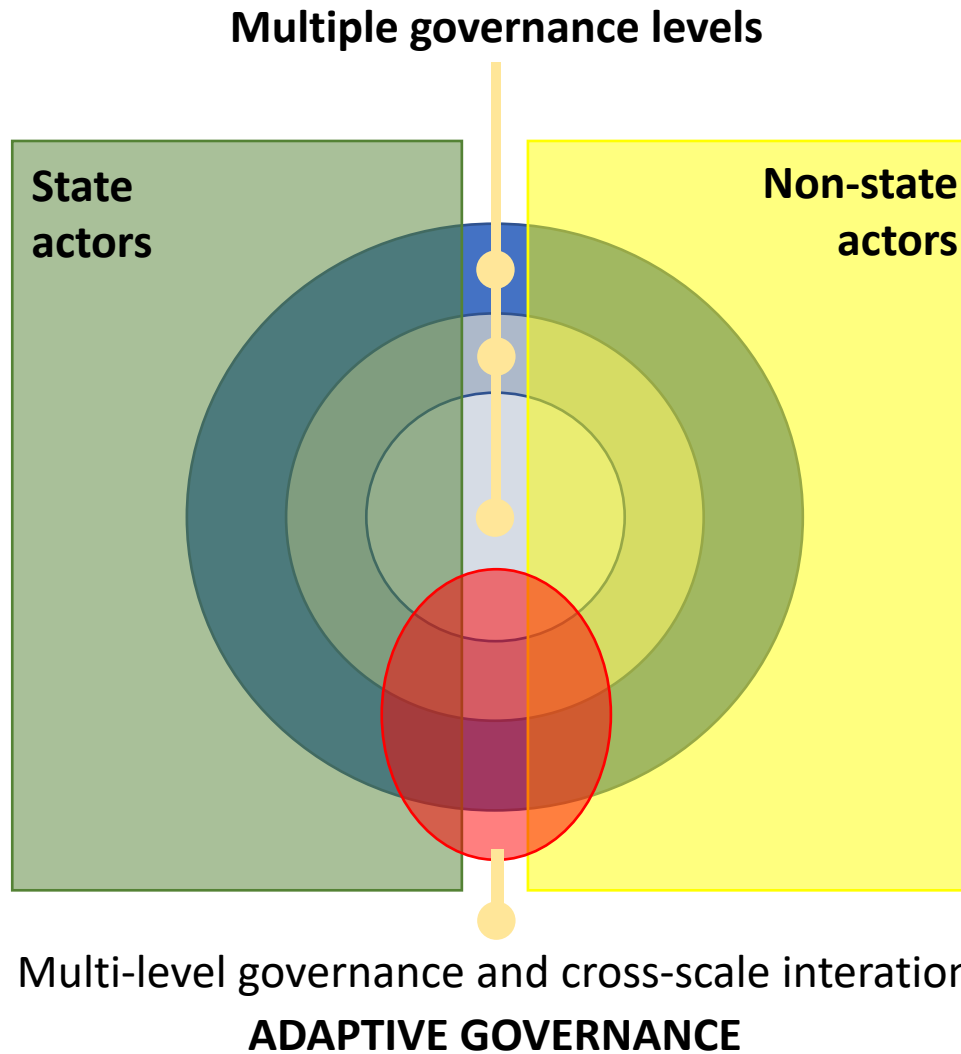


# Steps for Disaster & Climate Resilient Adaptive Governance

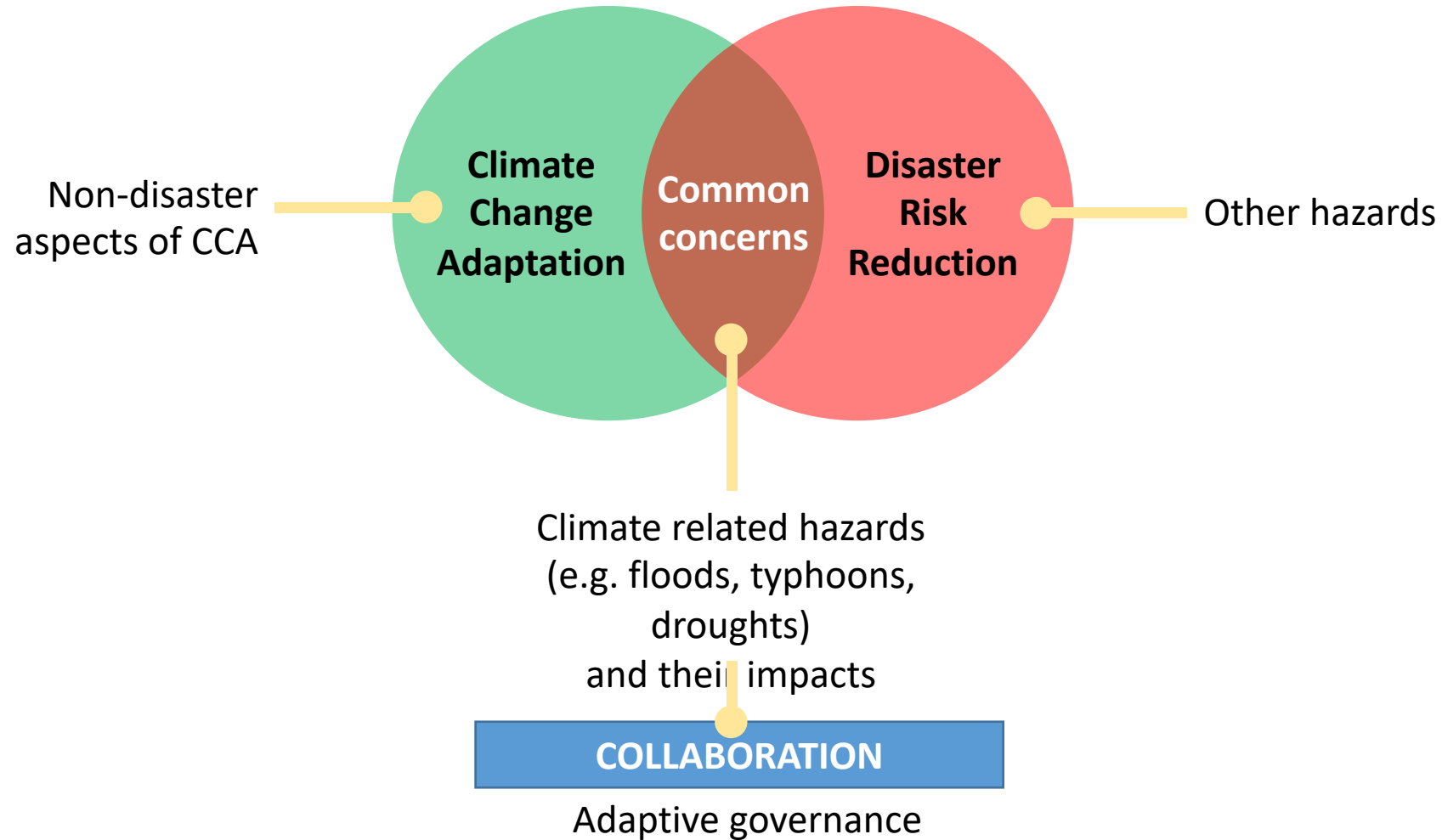
# Principles of Adaptive Governance

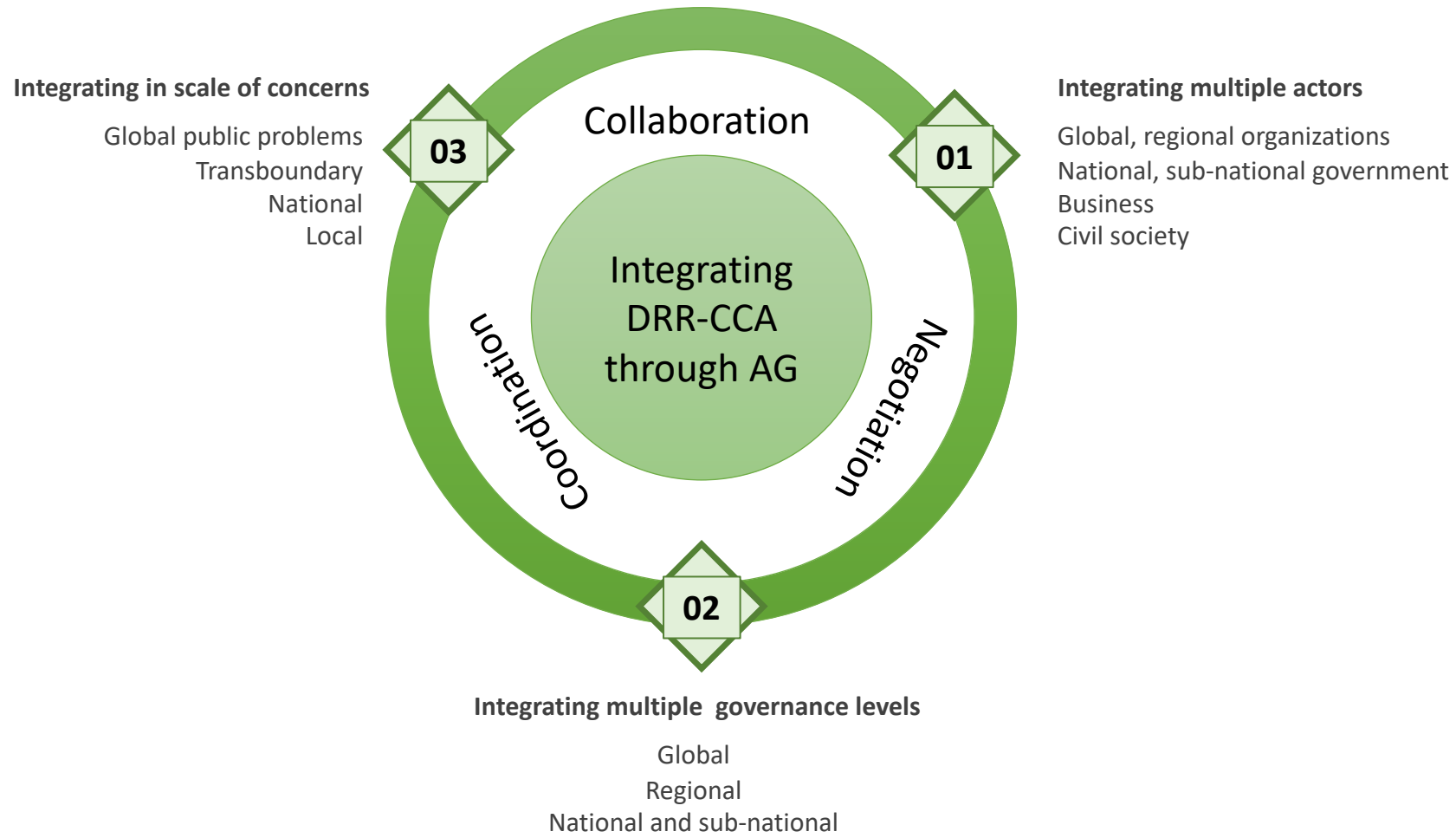

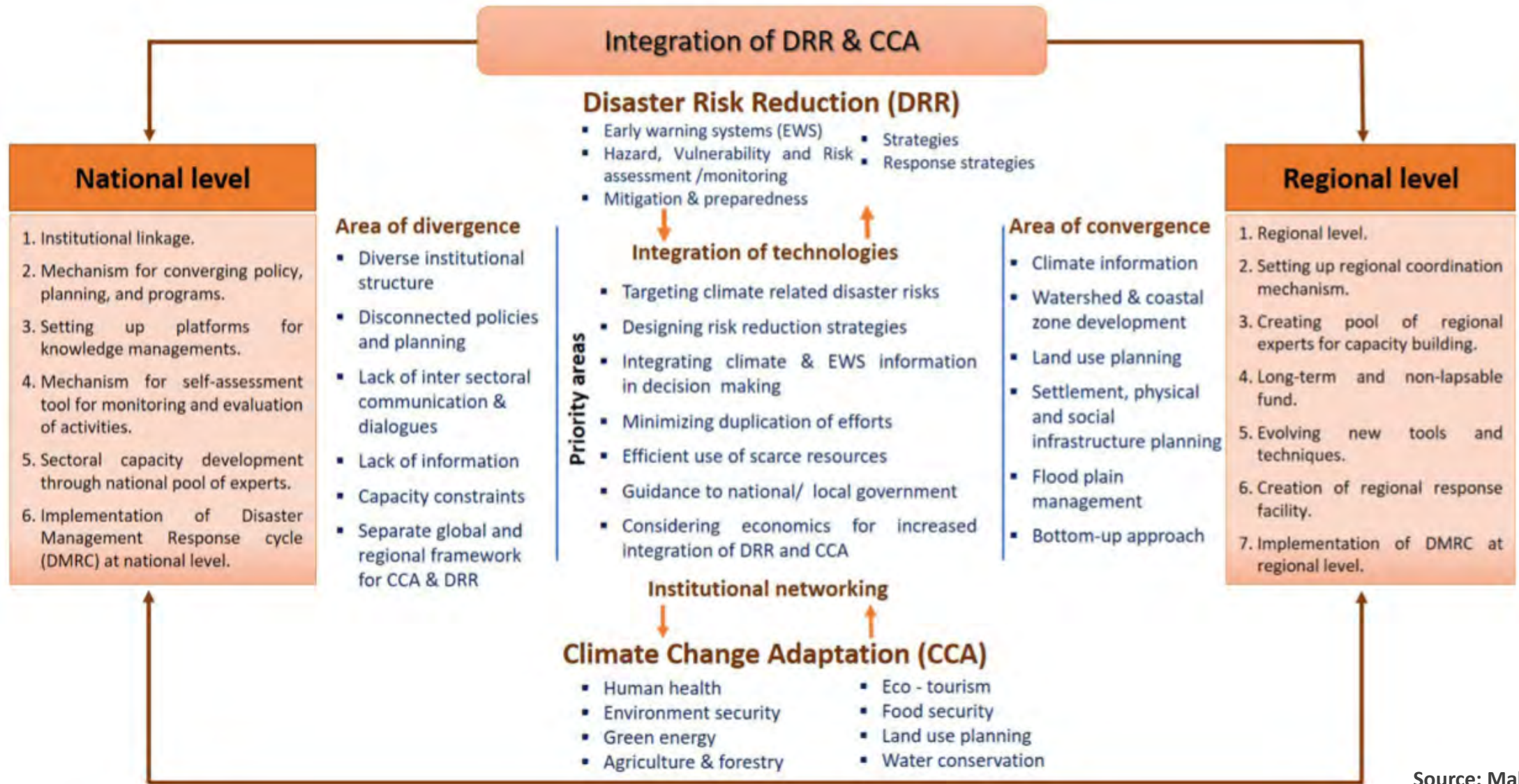
